Acting President Suydam called the meeting to order at 6:32 PM.October meeting board minutes were approved unanimously after motions by Long and Lapp.

The Board approved unanimously after motions by Long and Spicher the resignation as Board president Ken Bookhamer effective November 7, 2022 per his written notice at an Executive Officer meeting that evening.

Lapp reported meeting will be held on November 16,2022 to plan for Coffee House program to be held January 2023, Talent Show to be held Spring of 2023. Cookies are needed for the Greenwood Park Open House to be held December 4, 2022

No Facilities and Grounds meeting or report. Cook and Spicher volunteered to be members of this committee with Smead and Operations Manager Jay Hurley. It was noted that various signs will be installed on school property as previously discussed.

Rupert discussed that School Paper Recycling will continue but changes are under review.

Rupert reported that Meat Raffle is being held at present time as fund raiser and plans for pretzel sandwich will be forthcoming. It was noted that School Librarian Michelle Sunderland will again arrange for "Library Night" with date to be determined.

The Board discussed various ways to treat the SVCCS staff during the Christmas season to show our appreciation to them. Details to follow by next meeting.
